F-1 REINSTATEMENT APPLICATION

An F-1 student, who has violated the USCIS rules and regulations (whether intentionally or unintentionally) is considered to be out of status. Once an F-1 student is out of status he/she must file for reinstatement with USCIS within five months. Otherwise he/she will become "unlawfully present."

The Illegal Immigration Reform and Immigrant Responsibility Act of 1996 (IIRIRA) section 301 amended stipulates:

"an alien who has been unlawfully present in the USA for more than 180 days, but less than one year, is inadmissible for three years, and an alien who has been unlawfully present for one year or more is inadmissible for ten years."

So it is very important to keep your status or apply for reinstatement on time.
